For commercial participants, your items, displays, products and services must relate directly to wood in some logical manner. Applicants will be classified into following categories.

**Crafter:** Those crafters who make WOOD items themselves and are available for sale. (Disqualified items on display will be requested for removal during this event.)

**Club:** Any club, organization, association that is wood-related and holds a non-profit (IRS) status.

**Commercial:** Any business that has wood related products, supplies and/or equipment. Any business that contracts for wood related services.
